### Funding needs for the AR6 cycle and possible funding sources

#### Funding needs

At IPCC-42 (Dubrovnik, October 2015) the Panel requested the Secretariat to explore the possibility of producing an overview of the costs associated with AR5 cycle and its products. The purpose of this overview is to serve as a financial guide in terms of planning and preparation for the Sixth Assessment Report (AR6). The areas covered in this overview include meetings, publications and their distribution as well as the costs associated with hosting of the Technical Support Units (TSUs).

The main meetings organized during the AR5 cycle included scoping meetings, Lead Author meetings, Core Writing Team meetings and Panel approval and acceptance sessions for reports. Overall a regional balance was maintained in the locations where the meetings were held.

In addition to the three Working Group contributions to the AR5 and the Synthesis Report (SYR), two Special Reports were published during the AR5 cycle, namely: *Renewable Energy and Climate Change Mitigation (SRREN)* and *Managing the Risks of Extreme Events and Disasters to Advance Climate Change Adaptation (SREX)* in 2011 and 2012 respectively. The Task Force on National Greenhouse Gas Inventories published two Methodological Reports in 2014, namely: *2013 Revised Supplementary Methods and Good Practice Guidance Arising from the Kyoto Protocol* and *2013 Supplement to the 2006 IPCC Guidelines for National Greenhouse Gas Inventories: Wetlands*. The distribution of the above-mentioned publications took place throughout the AR5 cycle.

Financial support to the TSUs was provided by their respective host country. Working Group I was supported by Switzerland, Working Group II was supported by the United States of America, Working Group III was supported by Germany and TFI was supported by Japan. The SYR TSU was jointly supported by Netherlands and Norway and it also received funding from the IPCC Trust Fund.

A snapshot of the costs associated with the AR5 cycle and its products is provided in **Annex 1**.
