This is as follows:

2. Nomination and selection of Co-ordinating Lead Authors, Lead Authors and Review Editors

This process will take place immediately following Plenary XXI and will continue into the spring of 2004. Every effort will be made to: achieve a balanced geographical representation of experts; increase the involvement of experts from developing countries and countries with economies in transition, and also of younger scientists new to the IPCC process; encourage the participation of experts from industry and business, and from development and environmental organisations.

3. Author meetings

In addition to the LA meetings followed successfully in the TAR, it is planned to organise smaller meetings of authors of individual chapters. These are intended to enable progress to be made in integrating new knowledge, particularly in fields where science has made quite rapid progress. Three such chapter meetings are currently envisaged for 2005.

4. Expert meetings

A number of expert meetings have been organised to address specific scientific issues that will feature in the Assessment:

a) Expert meetings that have already taken place:

- Climate Change and Water (all working groups involved, WGII Lead) (11-12 Nov 2002, Geneva, Switzerland)
- Climate Change and Sustainable Development (Joint WGII/III) (6-7 Mar 2003, Colombo, Sri Lanka)
- Mitigation and Adaptation (Joint WGII/III) (20-22 May 2003, Geneva, Switzerland)
- Observed Effects of Climate Change (WGII) (17-19 Jun 2003, New York, USA)

b) Expert meetings planned:

A number of expert meetings are planned by WGII:

- On Article 2 of the UNFCCC and key vulnerabilities (all Working Groups involved, WGII Lead), tbc provisionally 24-27 March 2004, Buenos Aires, Argentina
- > On Climate Change and Water (all Working Groups involved, WGII Lead), date and venue tbc

In addition there are a number of other cross-working group expert meetings envisaged for which it is important to include experts nominated by WGII:

- Second Expert Meeting on Climate Change and Sustainable Development (WGIII lead)
- Expert Meeting on Risk and Uncertainty (WGI lead)
- Expert Meeting on Regional Issues (WGI lead)
- Expert Meeting on Technology (WGIII lead)
- Second Expert Meeting on Adaptation and Mitigation (WGIII lead)
- Second Expert Meeting on Article 2 of the UNFCCC and key vulnerabilities (the need for this depends on outcome of the first meeting on this subject)
- Expert meeting on Long Term Mitigation and Stabilisation Scenarios

5. Guidance papers for authors

Two guidance papers for authors will be developed in time for consideration by authors at their first meeting in 2004:

- a) Characterisation of climate and other scenarios for the WGII Assessment. This will be similar to that developed for the WGII SAR and TAR, its purpose being to ensure that a broadly common set of assumptions is adopted by WGII authors.
- b) Description of uncertainty and expression of confidence levels, to achieve a common approach to these descriptions. This will be similar to that incorporated in TAR.

6. Budget for the IPCC Trust Fund.

The expected cost of author and expert meetings is as follows:
