1. ADOPTION OF THE AGENDA

The ExCom adopted the provisional agenda of the meeting (EXCOM-XVIII/Doc.1), as attached as **Annex 1**.

2. MATTERS OF COORDINATION

2.1 Translation Process

The Secretary referred to the proposal on the process for the translation of the IPCC reports, developed in consultation with the WMO Language, Conference and Publishing Services Department. She reported that the translators welcomed the possibility of a quality check of their work by IPCC scientists channelled to them through a single point of contact. Each Working Group (WG) and Task Force on National Greenhouse Gas Inventories (TFI), or the Chair in the case of the Synthesis Report (SYR) can use a team of scientists to review the draft translations; however, the communications with the translators will be through a single point of contact for each language and report (WG/TFI/SYR), as described in the proposal. The ExCom endorsed the proposal as drafted on 21 March 2013.

The ExCom agreed that the AR5 Glossary and Table of Contents will be translated as soon as possible, with the understanding that changes may intervene in the course of the final stages of preparation of the report.

2.2 Status of English version of IPCC reports as the document of record

The ExCom agreed that the English version of IPCC reports is the only version of record as it is the only one to have undergone the entire process of approval. This needs to be stated in preface format in every report of the IPCC including the officially translated ones. Nonetheless, the versions officially translated in the other UN languages are official products of the IPCC.

3.2 Posting of errata

The ExCom endorsed the proposal by C. Field, Co-Chair, WG II, communicated by email to the members on 14/3/13, that the electronic document of record of IPCC reports, clearly marked as such on the website, cannot be changed. The website needs to indicate that corrections are in a separate file. There will be a downloadable "working version" in which the text has not been modified in any way, but in which flags are inserted in the text, containing or linking to corrections. With this approach, it is clear which text is original and what the changes are. The "working version" needs to be described as such on the web site, along with a direction to check the document of record version if there are any questions about authenticity. Note added following the meeting for clarification: it is proposed that this system be implemented starting with the AR5 cycle and the two Special Reports SRREN and SREX.

4. COMMUNICATION AND OUTREACH ACTIVITIES: POLICY ON SOCIAL MEDIA

Under this item, the ExCom first discussed the policy for the preparation of op-eds. Members spoke in favour of releasing op-eds in line with the current findings of the IPCC, but against addressing complex technical issues in op-eds. Regarding the recent proposal by the Communications Manager to prepare an op-ed signed by the IPCC Chair on the occasion of the release of the *WMO Statement on the Status of the Global Climate 2012*, it was suggested to monitor the reactions to this document and the possible questions that may arise after its release, and then decide whether the IPCC should issue an op-ed and revise the draft Chair's op-ed accordingly.

The JWG is open to the ExCom members who will be at the UNFCCC meetings being held in Bonn at that time. The Secretary will continue liaising with the UNFCCC Secretariat to finalize the arrangements. The latter will send out the JWG invitations and agenda when finalized.
