# 2.1 Correction of errors in the Fifth Assessment Report (AR5) Working Group I (WGI) Summary for Policymakers (SPM)

T. Stocker, Co-Chair, WGI, recalled that, following the approval of the AR5 WGI SPM and its release on 27 September 2013 subject to copy-edit and final layout, the authors of the report had discovered some errors in the SPM. These errors were being handled in accordance with the *IPCC Protocol for Addressing Possible Errors in the IPCC Assessment Reports, Synthesis Reports, Special Reports and Methodology Reports* (the Error Protocol). In particular, the Panel had been notified about the errors and the proposed corrections with a letter from the IPCC Secretariat on 31 October and had agreed to delegate the approval of the errata to the Executive Committee.

In keeping with the authority delegated by the Panel, the ExCom approved the errata provided by the Co-Chairs of WGI and already approved by the WGI Bureau.
