Note on 2006 contribution by the European Commission to IPCC Trust Fund

A contribution agreement had been signed between the European Commission (EC) and WMO to the benefit of the IPCC Trust Fund in support of the preparation of the Fourth Assessment Report. This is the procedure required to get contribution to the IPCC Trust Fund from the EC. The project, which had to be developed within the overall framework of the IPCC workprogramme and budget, was aimed at supporting the preparation of the summaries of the three Working Group reports in all UN languages (Technical Summaries-TS and Summaries for Policy Makers-SPM), their publication and the preparation for outreach activities on the AR4.

The contribution of 200 000 euros had to be spent during the period 15/07/2006-14/07/2007 and was specifically aimed at supporting the participation of scientists from developing countries and countries with Economy in Transition (EIT) in writing team meetings, to cover the salary of a consultant for graphics work, to contribute to the cost of publication and translation in UN languages of Working Group report summaries, and to contribute to the salary of a communication officer for outreach activities.

An initial payment of 160 000 euros was made by the EC in 2006 and is included in table 2 above. All operations were conducted according to the terms of the contribution agreement, however the publication and translation activities were delayed compared to the schedule agreed in 2006, but still initiated during the contractual period. In spite of arguments raised by the WMO administration and after several exchanges of mail, the EC finally rejected the eligibility of the corresponding costs to the contribution agreement. This results in a decrease by 82616 euros of the 2006 EC contribution and the need to reimburse them 42616 euros from the Trust Fund. The originally agreed contribution from the EC of 200.000 Euros is thereby reduced to 117.384 Euro.
