Sir/Madam,

I am writing on behalf of the Chairman of the Intergovernmental Panel on Climate Change (IPCC) to advise that (a) the Eleventh Session of Working Group III of the Intergovernmental Panel on Climate Change (IPCC) from 5-8 May 2011 and (b) the Thirty-third Session of the IPCC from 10-13 May 2011 will both take place at Abu Dhabi National Exhibitions Centre (ADNEC), Abu Dhabi, United Arab Emirates.

Main agenda item of the Eleventh Session of IPCC Working Group III will be acceptance and approval of the IPCC Special Report on "Renewable Energy Sources and Climate Change Mitigation" and its Summary for Policymakers (SPM). The Session will begin at 10:00 hours on Thursday, 5 May 2011. After action by the Eleventh Session of Working Group III the SPM of the Special Report and the underlying assessment will be forwarded to the IPCC for its action.

The Thirty-third Session of the IPCC is scheduled to begin at 10:00 hours on Tuesday, 10 May 2011. The focus of this meeting will be on: a) the acceptance of the actions of the Eleventh Session of the IPCC Working Group III; b) consideration of the task groups recommendations related to the InterAcademy Council review of the IPCC.

Simultaneous interpretation in the official UN languages (Arabic, Chinese, English, French, Russian and Spanish) will be provided during the plenary meetings. All documentation will be in English only. Copies of the following documents are attached to this letter:

1. The provisional agenda of Working Group III Eleventh Session (WG-III:11<sup>th</sup>/Doc.1);
2. The provisional agenda of the IPCC Thirty-third Session (IPCC-XXXIII/Doc.1);
3. A registration form.

Box 2300, 7bis Avenue de la Paix, CH-1211 Geneva 2, Switzerland (fax: +41 22 730 8025/8013) by **31 March 2011**. Unfortunately nominations by e-mail cannot be accepted. As an intergovernmental organization we must have your nomination(s) sent by letter or fax on official letterhead. In addition, to facilitate pre-registration, each participant is kindly requested to complete the attached registration form. As you may have noted, the participation of delegates with appropriate expertise is vital for the success of the session.

Limited financial support is available from the IPCC Trust Fund to representatives from the developing countries and countries with economies in transition. Nominations for financial support should reach me no later than **23 March 2011**. I request that this deadline be strictly adhered to because of the time required for the logistics of delivering the support.
