Sir/Madam,

I am writing on behalf of the Chairman of the Intergovernmental Panel on Climate Change (IPCC) to advise that the Twenty-Seventh Session of the IPCC is scheduled to take place at "El Museo de Ciencias", located in "La Ciudad de las Artes y las Ciencias", Avenida Autopista del Saler nº 1-7, 46013 Valencia, Spain, from 12-17 November 2007.

The Twenty-Seventh Session of the IPCC is scheduled to begin at 10:00 hours on Monday, 12 November 2007. The focus of this meeting will be on the adoption and approval of the draft Synthesis Report of the IPCC Fourth Assessment Report (AR4). The Chairman will also introduce a discussion paper about the future of the IPCC and take up other items that require consideration and decision by the Panel, as indicated in the attached agenda.

Simultaneous interpretation in the official UN languages (Arabic, Chinese, English, French, Russian and Spanish) will be provided during the session. All documentation will be in English only. Copies of the following documents are attached to this letter:
