#### PROVISIONAL ANNOTATED AGENDA

The Forty-Sixth Session of the IPCC (IPCC-46) will take place from 6 to 10 September 2017 at the International Civil Aviation Organization (ICAO) headquarters, 999 Boulevard Robert-Bourassa, Montréal, QC H3C 5H7, Canada.

Simultaneous interpretation in Arabic, Chinese, English, French, Russian and Spanish will be provided during the plenary Session. All documentation will be in English only.

Pre-session documentation will not be distributed on paper but will be posted on a dedicated web page at <a href="www.ipcc.ch">www.ipcc.ch</a>. In addition, the IPCC papersmart system will allow registered participants to access session documents in electronic format during the meeting on a dedicated web portal via individual credentials linked to their registration. Specific guidance on the use of the papersmart system is made available in advance of IPCC sessions. Participants are encouraged to download the documentation on their computers in advance of the session.

## 2. APPROVAL OF THE DRAFT REPORT OF THE 45<sup>TH</sup> SESSION

A first draft of the report of the 45<sup>th</sup> Session of the IPCC was distributed by the Secretariat to the members of IPCC, with a request to submit written comments. Comments received within the set deadline have been incorporated in the document, <a href="IPCC-XLVI/Doc.5">IPCC-XLVI/Doc.5</a> that will be presented to the Panel for final approval.

## 3. IPCC TRUST FUND PROGRAMME AND BUDGET

3.1 Budget for the years 2018, 2019 and 2020

The Panel will be invited to consider document <a href="IPCC-XLVI/Doc.2">IPCC-XLVI/Doc.2</a> and adopt the decision approving the revised 2018 budget and note the budgets for 2019 and 2020.

The Panel will be invited to urge member governments that have not yet done so to make their 2017 contributions, and invite member governments in a position to do so to make multi-year pledges covering 2017-2019 and beyond.

The Secretariat will present document <a href="IPCC-XLVI/Doc. 4">IPCC-XLVI/Doc. 4</a> on Communication and outreach for the Special Reports in the Sixth Assessment Report Cycle.

## 4. AD HOC TASK GROUP ON FINANCIAL STABILITY (ATG-Finance)

The Chair of the IPCC will introduce the agenda item by providing a general overview of the scoping process and note the documents before the Panel and the Plenary sessions of the three Working Groups. The Chair will explain that the Panel session will be adjourned for the Working Group Plenary sessions to be held on 7 and 8 September. The Plenary will reconvene on 9 September in the morning for approval of the outlines as agreed to by the three Working Group plenaries and on cross cutting matters and to provide further guidance as appropriate.
