PROVISIONAL ANNOTATED AGENDA

The Forty-First Session of the IPCC (IPCC-41) will take place from 24-27 February 2015 at the Headquarters of the United Nations Environment Programme (UNEP), United Nations Avenue, Gigiri, Nairobi, Kenya.

Simultaneous interpretation in Arabic, Chinese, English, French, Russian and Spanish will be provided during the plenary meetings of the Session. All documentation will be in English only.

Pre-session documentation will not be distributed on paper but will be posted on a dedicated web page at www.ipcc.ch. In addition the IPCC papersmart system will allow registered participants to access session documents in electronic format during the meeting on a dedicated web portal via individual credentials linked to their registration. Specific guidance on the use of the papersmart system is made available in advance of IPCC sessions. Participants are encouraged to download the documentation on their computers in advance of the session.

It is suggested that the working hours be from 10.00–13.00 and from 15.00–18.00 hours.

As the 41st Session is expected to take a number of decisions which will have budgetary implications for the coming years it is suggested that the budget for 2016 and the following years will be considered at the 42nd Session to allow for adequate preparation.

options of producing a Technical Paper or a Special Report, or to address the matter otherwise in the forthcoming assessment cycle. A progress report about the preparations for the meeting will be presented.

In response to proposals received from the International Geosphere-Biosphere Programme (IGBP) and the United Nations Environment Programme (UNEP) sponsored Programme of Research on Climate Change Vulnerability, Impacts and Adaptation (PROVIA) for workshops on lessons learnt from the Fifth Assessment Report (AR5) to identify scientific gaps in knowledge that cut across Working Groups I, II and III the Panel at its 40th Session agreed to convene a “Lessons Learnt workshop”. The IPCC Secretariat will provide an update on the preparations for that meeting.

The Panel agreed at its 39th Session to convene a scenarios meeting. The Co-Chairs of Working Group III will present a progress report about the preparations for the “Working Group III Scenarios Meeting” which will be held in May 2015 in Laxenburg, Austria.

The 42nd Session of the IPCC is planned to be held in October 2015.
