### Requests for workshops on lessons learnt from AR5 Proposals received from IGBP and PROVIA

Proposals for workshops on lessons learnt from the Fifth Assessment Report (AR5) to identify scientific gaps in knowledge that cut across Working Groups I, II and III were received from two international bodies, the International Geosphere-Biosphere Programme (IGBP) and the United Nations Environment Programme (UNEP) sponsored Programme of Research on Climate Change Vulnerability, Impacts and Adaptation (PROVIA).

It may be recalled that after completion of the IPCC Fourth Assessment Report (AR4) two meetings addressing gaps in knowledge identified in the AR4 were held jointly with relevant research programmes. A Workshop on "Future Climate Change Research and Observations: Learning from the IPCC Fourth Assessment Report" was held jointly with GCOS (Global Climate Observing System), WCRP (World Climate Research Programme) and IGBP from 4-6 October 2007 in Sydney, Australia. A workshop on "Future Climate-Change Response Research: Learning from IPCC's Fourth Assessment", involving the ESSP (Earth System Science and Partnership) programmes: DIVERSITAS (International programme of biodiversity science), IGBP, IHDP (International Human Dimensions Programme on Global Environmental Change) and WCRP was held in Amsterdam, in January 2009.

At its 39<sup>th</sup> Session the Panel agreed to the proposal by IPCC Working Group I Co-chairs to hold a joint workshop with WCRP in Bern in September this year on "IPCC AR5: Lessons Learnt for Climate Change Research and WCRP" and approved travel support for IPCC speakers at this joint workshop.

The Panel is invited to consider the attached initiatives from the the International Geosphere-Biosphere Programme (IGBP) and the Programme of Research on Climate Change Vulnerability, Impacts and Adaptation (PROVIA). It may consider them as two different initiatives or may wish to advice to hold a joint meeting. The Panel may further decide allocate the appropriate funds in the 2015 Budget.

Dear Dr. Christ,

Congratulations on completing IPCC AR5. This is a major accomplishment. Following the publication of the previous assessment, AR4, the IPCC and international research programmes including IGBP sponsored a workshop to identify knowledge gaps. This resulted in an influential paper (Doherty et al. 2009 Bull. Amer. Meteor. Soc., 90, 497–513.) to inform international and national research foci in climate-related fields, including adaptation and mitigation.

Looking forward to future assessments, each Working Group report of AR5 provides important guidance on the location of gaps in scientific knowledge. Clearly future assessments will require targeted advances in science relating to the biogeophysical climate system, climate-change impacts and vulnerability of human and natural systems, as well as mitigation options. To aid solutions development, early identification of the key research priorities that *integrate across these domains*, including the dynamic interactions among these domains, is important.

I would like to propose IPCC co-organizes a workshop(s) with the international research community to identify scientific gaps in knowledge that cut across AR5 WGI, II and III. The aim of the workshop is to produce a report or paper to help guide national and international research agendas. Such an initiative could be co-organized by IPCC with international research programmes.
