# International Conference on Climate Risk Management

#### **Background:**

Increasingly, the audience for information on vulnerability, impacts and adaptation has broadened from just UNFCCC policy makers. There are opportunities to better organize the next IPCC assessment to respond to their needs, and while doing so also better serve the UNFCCC. A particular user community is the international community dealing with climate and disaster risk management, particularly in vulnerable contexts.

In order to inform the AR6 scoping process with this community's needs and insights, the Red Cross Red Crescent Climate Centre is convening an international scientific conference co-organized with partners working on the interface of climate science, policy and practice, and co-sponsored by IPCC.

Using innovative participatory methods, this conference will convene dialogue between humanitarians, development actors, scientists, and adaptation practitioners about the information and communication needs to translate scientific information into policy and practice, with a particular focus on managing risks facing the most vulnerable groups.

#### **Objectives:**

The outcomes of the 2017 Conference on Climate Risk Management will be to focus on those who are most vulnerable to climate change. It will (1) identify key metrics and formats in which researchers can present existing research and other types of climate risk information in a way that will better inform climate risk management for the most vulnerable, (2) identify key areas of research that are needed to inform climate risk management for the most vulnerable, and (3) inspire commitments to new research projects that will address these needs.

#### The conference will:

1. Bring together researchers and practitioners in a participatory dialogue on information needs for climate risk management that specifically address the needs of the most vulnerable

- 2. Identify key successes in climate risk management for the most vulnerable that have been influenced by previous IPCC assessment reports and other scientific literature
- 3. Compile information on stakeholder needs for climate risk information, both content and format
- 4. Identify areas of research needed to further promote and expand such successes to new regions, sectors, and stakeholders, in line with the priorities from COP22, the Sustainable Development Goals (SDGs), and the Sendai Framework for Disaster Risk Reduction
- 5. Develop key metrics and formats in which research can be presented to inform climate risk management for the most vulnerable
- 6. Encourage humanitarian and development sectors to implement evidence-based policies and programmes and participate in the co-design of research programmes
- 7. Establish a collaboration that will continue dialogue on the translation of scientific information into policy and practice.

### Travel and accommodation

#### Flights:

Once you have booked your flight please ensure that your flight information is sent to <a href="mailto:zoe@amygibsonevents.com">zoe@amygibsonevents.com</a>. If you are being fully funded, you should liaise directly with the assigned travel agent in order to book your flight. Please contact Raptim Travel at <a href="mailto:travelteam3.nl@raptim.org">travelteam3.nl@raptim.org</a> as soon as possible with your date of departure and return, country/city of origin, and any special requirements (dietary requirements, seat preference etc.). Please also state that you are attending the International Conference on Climate Risk Management meeting.

If you are being funded by IDRC please communicate with <u>Ahmed</u> in order to book your flights. If you are self funded please book your flights through your own means as soon as possible and ensure that your flight information is sent to both <u>zoe@amygibsonevents.com</u> and <u>Masha</u> at the Boma Hotel to ensure that your airport transfers are booked.

We ask you to arrive on Tuesday 4th April and depart on either the evening of 7th April or any time on 8th April. Flights should be confirmed by 20th March.

#### Accommodation and airport pick-ups:

If you are being funded by the organisers your accommodation and airport pick up will be covered. Once your have confirmed your flights and sent the details to us, we will book your room and airport transfer. If you are self funded you will need to cover the cost of your accommodation and airport transfers, both of which can be booked directly with the hotel. Please send your travel details to <u>Masha</u> in order to do this.

#### Visas:

You need a visa to enter Kenya which you will need to obtain before you travel. You can apply for single entry and transit visas on the <u>evisas website</u>, where you can also find your eligibility. Please note that it takes approximately 1 week for a visa to be processed, and usually costs \$51. If you have been told that your costs will be covered by the organisers, please bring your visa receipt to the event in order to be reimbursed in cash.

In order to receive the necessary invitation letter, please <u>FILL IN THE FORM HERE</u> so we can create your letter and return it to you for your visa application.

Please note: your passport should be valid for a minimum period of 6 months from the date of entry into Kenya. Make sure you have two blank pages in your passport on arrival.

#### Dinners and other expenses:

If you are being fully covered by the organisers the cost of your meals will be covered (breakfast, lunch and dinner at the hotel as well as conference tea and snacks). If you are being funded by IDRC please communicate with <u>Ahmed</u> on your expenses.

If you are self-funding then your breakfast will be covered in the cost of your accommodation, and your lunch and conference tea and snacks will be covered by the organisers. However you will be expected to pay for your own dinners.

We advise that you arrange travel/health insurance for your trip, but this will not covered by the organisers.


#### Venue:

### Travel health and safety

#### **Vaccinations**

We recommend you consult your GP or travel nurse 4-6 weeks prior to travelling to Nairobi.

Please see here for a list of necessary vaccinations.

Yellow fever: There is risk of yellow fever transmission in parts of Kenya. The government of Kenya requires proof of yellow fever vaccination only if you are arriving from a country with risk of yellow fever transmission.

#### Travel insurance

Please make sure that you have travel insurance provided by your employer.

#### Stay healthy

We recommend you consult your GP before travelling to ensure you are in good health and to enquire about any over-the-counter medication you may need.

April is a fairly hot month for Kenya with maximum temperatures ranging from 25 - 30 degrees celsius. Make sure you stay protected and hydrated at all times, and follow these simple steps to stay healthy on your trip.

- 1. Stay hydrated, drink water at regular intervals throughout the day
- 2. Drink only boiled or bottled water and avoid ice in drinks
- 3. Don't eat food prepared by unlicensed vendors
- 4. Carry high UV protection sunscreen, sunglasses and a hat
- 5. Wash your hands often, particularly before eating
- 6. Eat cooked, hot food. Avoid raw, undercooked or soft meat, fish or eggs
- 7. Cover exposed skin and wear insect repellent to avoid mosquito bites
