1. ADOPTION OF THE AGENDA

The Head of Communications informed the ExCom of recent outreach and future activities, as outlined in Annex 2, including media activities following the 49th Session of the IPCC and adoption and acceptance of the *2019 Refinement*, recent outreach activities, plans for videos for the two forthcoming special reports, and progress on the contract for publications in the Sixth Assessment Cycle.

The IPCC Chair expressed appreciation for the work of the communications team and contribution of authors and Bureau members in the outreach activities. He requested the Secretariat to inform the authors of the IPCC Special Report on Global Warming of 1.5°C of progress in organizing the publication of the report.

ExCom Members underlined the importance of organizing Digital Object Identifiers (DOIs) for the report.

The ExCom took note of the report.

4.1 Update on the implementation of the Error Protocol and follow up

The Secretary of the IPCC informed the ExCom of closed and pending claims, as highlighted in the note sent to the ExCom members in advance and urged Working Groups to address the claims as soon as possible.

Members informed the ExCom of progress in addressing some claims.

The ExCom took note of the update.

The Secretary of the IPCC informed the ExCom about the logistics for the forthcoming 50th Session of the IPCC, which will consider the approval and acceptance of the Special Report on *Climate Change and Land*.

Participants discussed the need to make the most effective and efficient use of the time and the Bureau resources available in line with the procedures for managing sessions.

The ExCom took note of the information.

6.1 Task Group on Data Support for Climate Change Assessments (TG-Data)

In response to a question, the Secretary of the IPCC informed the ExCom that the Secretariat was working on the additional nominations for TG Data on the basis of the decision taken at the 49th Session of the IPCC, and would inform the ExCom when there is progress to report.

6.2 2019 Refinement to the 2006 IPCC Guidelines for National Greenhouse Gas Inventories" (2019 Refinement)

The ExCom took note of the advice previously provided by the Legal Officer of the IPCC about the formatting of the *2019 Refinement* Methodology Report and the Report of the 49th Session of the IPCC.

- Chapter 10 of the WMO Standing Instructions states that "The objective of the procurement activities within the WMO is to achieve best value for money for the acquisition of goods and services in a manner that supports fairness, integrity and transparency, and is directed towards maximum economy and effectiveness within, and in accordance with the objectives of the Organization."
- It also states "The members of a [Technical Evaluation Board] are appointed in their personal capacity and shall not disclose information received as part of the tender process to others outside the Board with the exception of the [Procurement and Contract Management Division]."
- Last year the Secretariat prepared a request for proposals to publish the full report to be produced in the Sixth Assessment Cycle, consulting with the TSUs on the specifications.
- The WMO posted the RFP on 3 September. Only one vendor submitted a proposal, but was disqualified when the technical bids were opened as it did not meet the WMO procurement process rules.
- A second RFP was launched on 26 November. Technical bids were opened on 20 December, and financial bids on 8 April 2019.
- The evaluation is being prepared and will be considered by the relevant WMO body under the Standing Instructions.
