### 1. ADOPTION OF THE AGENDA

# 3.1 Ongoing and planned activities, including:

- Publication of the SR15 Report
- Informal Bureau group on publications
- Allocation of DOI numbers and open access translations
- J. Lynn, Head of Communications, informed the ExCom of ongoing and planned communications activities, as outlined in Annex 2, and highlighted the establishment of the IPCC-WMO Science Pavilion thanks to the generous support of the Government of Chile, Chilean foundation Filantropía Cortés Solari, and the UNFCCC. Among the many people who contributed to the success of this project, which has raised the visibility of the IPCC at COP 25, are the three IPCC Vice-Chairs, who

served as a scientific steering committee to develop the programme of events, and Secretariat staff J. Baidya and N. Peeva, who worked tirelessly to overcome practical obstacles.

ExCom members thanked all concerned for contributing to the successful establishment of the pavilion and its programme.

The ExCom took note of the communications report.

Mr Lynn reported that a proposal on enhanced communications materials for outreach had been submitted to the Bureau. Pending a final decision by the Bureau on this, a proposal to develop materials for a series of outreach events in Africa had been developed and approved by the Working Group Co-Chairs. The Co-Chairs will now scope these materials, and the UN Foundation will prepare them, submitting them to the Co-Chairs for review before completing them for final sign-off.

The ExCom reviewed options for publication, including minting Digital Object Identifiers (DOIs) for the three Special Reports and their component parts. The ExCom considered factors such as the time required by different providers, printing and publishing options, costs, the quality and other services offered by different providers, and the possible contribution of the TSUs in facilitating a solution. Members noted that the ExCom cannot commit national funders of TSUs to any funding, and that any solution must not compromise the scientific credibility of the IPCC.

The ExCom invited the Secretariat to develop some options further in cooperation with the Working Group Technical Support Units, and in consultation with WMO.
