**Opening Statement by IPCC Chair Hoesung Lee** 

Distinguished Government Representatives, Dear Colleagues

This is the second time the Panel has met in a remote format, following the 53<sup>rd</sup> Session earlier this year dedicated to the Budget.

This form of working imposes extra demands on all of us.

I would like to thank the Secretariat for all the work they have done to ensure that this meeting can take place efficiently and inclusively, and drawing on the experiences and feedback from our unprecedented virtual and hybrid meetings of the past 12 months. We will also be addressing the review of the Principles Governing IPCC Work, and hearing a a series

of progress reports on the full range of IPCC activities.

I take this opportunity to thank the Working Group and TFI co-Chairs, respective TSUs and in

particular the authors who volunteer their time and expertise for their great efforts to deliver under the

current challenging circumstances.
