2. URGENT ISSUES RELATED TO IPCC PRODUCTS AND PROGRAMME OF WORK THAT REQUIRE PROMPT ATTENTION BY THE IPCC BETWEEN PANEL SESSIONS

2.1 Schedule of the Synthesis Report of the Sixth Assessment Report of the IPCC

The Head of the Synthesis Report (SYR) Technical Support Unit (TSU) presented a revised schedule aiming for the SYR approval in October 2022. The timing would allow six weeks for the Final Government Review period and seven weeks to prepare the final draft.

The ExCom commented on the revised schedule as to its feasibility: many authors would not be available during the proposed first two weeks of the Final Government Distribution (from 6 to 16 June 2022) as they will be in Bonn, Germany, for the UNFCCC Subsidiary Bodies; the need for a contingency plan in case of the unavailability of the core scientific expertise and the risk of reputational damage; and more information on the support from the SYR TSU to authors.

The Chair concluded that the SYR TSU is to revise the schedule in consideration of ExCom's deliberations and the status of schedule revision will be communicated to the SSC and the Bureau.
