

# Kenya Visa Eligibility

Passport holders traveling to the Republic of Kenya are divided into 3 categories.

## Category 1

- Nationals and Persons who do not require visas to enter Kenya.

## Category 2

- Nationals and Persons who require visas to enter Kenya.
- Nationals issued with visas on application.
- Processed within 48 hours.

## Category 3

- Countries and Persons who require referred visas.
- Processed within 10 working days.
