Sixty-third Session of the IPCC (IPCC-63)

Lima, Peru 27 – 30 October 2025



### I. INTRODUCTION

The Sixty Third Session of the Intergovernmental Panel on Climate Change (IPCC) will take place in **Lima**, **Peru** from **27 to 30 October 2025**.

Peru, located in South America, is bordered with Ecuardor, Colombia, Brazil and Chile. With population of over 32 million, Peru is a megadiverse country, with habitats ranging from the arid plains of the Pacific coastal region in the west, to the peaks of the Andes mountains extending from the north to the southeast of the country, to the tropical Amazon basin rainforest in the east with the Amazon River.

The name Peru is derived from a Quechua word implying land of abundance, a reference to the economic wealth produced by the rich and highly organized Inca civilization that ruled the region for centuries. The country's vast mineral, agricultural, and marine resources long have served as the economic foundation of the country.

Peru is divided into 25 regions and its capital and largest city is Lima.

### **MEETING VENUE**

The Session will take place at ESAN Convention Center, in the western area of Lima. The address is Jr. Alonso de Molina 1652, Santiago de Surco, Lima, Peru.

## III. VISITORS TO LIMA, PERU

### 1. JORGE CHÁVEZ INTERNATIONAL AIRPORT

Participants are recommended to arrive at Jorge Chávez International Airport (IATA: LIM, ICAO: SPJC). It is located in Callao, 11 kilometers northwest of the Historic Centre of Lima and 17 kilometers from the district of Miraflores. In 2023, the airport served in excess of 23 million passengers. Historically, the airport was the hub for Compañía de Aviación Faucett, which was the second oldest airline in the Americas, and Aeroperú, which served as Peru's flag carrier.

### 2. TRANSPORTATION

Participants will be responsible for coordinating their own transportation to and from the airport.

## Taxi from/to Jorge Chávez International Airport

There are taxi booths that offer safe transport from the arrival area of Lima Airport to hotels at reasonable costs. After custom checks, head towards exit gate N° 02, where our staff holding IPCC-63 placards will give you guidance on 25 and 26 of October only. In their absence, after exiting gate N° 02, cross the first lane and on the island to your left, you will see the taxi booths for:

# Complementary Hotel Transfer or a Private Airport Transfer

Free hotel transfers are the best way to travel between the hotel and the airport. However, not all the hotels will provide a free shuttle.

### Taxi within the city

Delegates are strongly encouraged to use taxi applications such as Uber and Cabify for transport within Lima. Alternatively, ask your hotel for help to book a safe taxi ride.

Uber and Cabiyf are also allowed to come to the car park area of the airport, beyond the taxi booths.

### 3. TIME ZONE

Lima is UTC -5 hours.

All places in Peru are in the same time zone.

### 4. VISAS FOR TRAVEL TO PERU

Nationals who require a visa to enter Peru must complete the visa application process prior to traveling. The visa application process should be initiated and completed between one month and 15 days before the intended date of travel. Please note that Peru does not issue "visas on arrival" or "electronic visas."

Please note that the deadline for visa applications is **Friday, 10 October 2025**. Please note, it is of utmost importance for those delegates who need to secure a visa to do so as soon as possible and before the deadlines, otherwise a visa could not be guaranteed.

### **4.1 Visa Application Requirements**

- Submit the "FORMULARIO DGC-005 SOLICITUD DE VISA (DGC-005 Visa Application Form) duly signed by the Consul or the head of the Consular office.
- Provide a scanned copy of a valid passport (minimum validity of 6 months).
- Submit an official letter/note of nomination from the country/entity/organization accrediting the participant, including full names, passport numbers, contact details, purpose, and duration of the trip.
- Formal request letter for entry visa for each registered participant requiring a visa.
- Submit one recent color passport-size photograph, white background, without glasses.

# 4.2 Visa Application Procedure

Applications must be made in person. It is recommended that this procedure be carried out between 15 days and one month prior to the intended date of travel.

Visa applications may be submitted at any Peruvian Consular Office abroad, <u>except for Honorary Consulates</u>, <u>which do not issue visas</u>.

The processing fee is determined in accordance with the current consular tariff schedule, and the exact amount will depend on the respective consular office.

Please recall the following guidelines:

- It is the sole responsibility of each participant to obtain the necessary visa to enter
- Participants are responsible for ensuring that their passport meets all entry requirements, including minimum validity, and for carrying the required documentation when traveling. The information provided above is for guidance purposes only.
- Obtaining a visa for Peru is the exclusive responsibility of the delegate. The information contained herein is for reference only.
- All participants are strongly advised to carry copies of their letter of invitation, flight itinerary, and proof of lodging while traveling.

Please note that visa applications may fall into two possible scenarios:

# a. Applicants residing in a country with a Peruvian Consulate in their country

- Contact the nearest Peruvian Consular Office to schedule an appointment.
- Complete the visa application process between 15 days and one month prior to travel.
- Once approved, applicants must collect their visa in person at the designated consulate.

# b. Applicants residing in a country without a Peruvian Consulate

- Request an appointment at a Peruvian Consulate in a third country or in a country of transit prior to entering Peru.
- Complete the visa application process between 15 days and one month prior to travel.
- Ensure compliance with the entry requirements of the third country or country of transit where the visa will be issued.
- Once the visa has been approved, applicants must collect it in person at the consulate where the application was submitted, presenting the original receipt and valid identification, subject to prior coordination with said consular office.

### **4.3 Ordinary Passports — Visa Exemption**

For short stays, many foreign nationals are not required to obtain a visa to enter Peru, provided they meet certain conditions, such as holding a valid passport and, in some cases, presenting return tickets and proof of lodging.

Nationals of the following countries <u>must obtain a visa in advance</u> from any Peruvian Consulate abroad:

Afghanistan, Albania, Algeria, Angola, Armenia, Azerbaijan, Bahrain, Bangladesh, Benin, Bosnia and Herzegovina, Botswana, Burkina Faso, Burundi, Bhutan, Cabo Verde, Cambodia, Cameroon, Central African Republic, Chad, Comoros, Cuba, Democratic Republic of the Congo, Republic of the Congo, Côte d'Ivoire, Djibouti, Egypt, Equatorial Guinea, Eritrea, Eswatini, Ethiopia, Gabon, Gambia, Ghana, Guinea, Guinea-Bissau, Haiti, Indonesia, Iran, Iraq, Jordan, Kazakhstan, Kenya, Kyrgyzstan, Kuwait, Laos, Lebanon, Lesotho, Liberia, Libya, Madagascar, Malawi, Malaysia, Maldives, Mali, Mauritania, Mauritius, Morocco, Mozambique, Myanmar, Namibia, Nepal, Nicaragua, Niger, Nigeria, North Korea, Oman, Pakistan, Palestine, Rwanda, Saudi Arabia, Senegal, Seychelles, Sierra Leone, Somalia, South Sudan, Sri Lanka, Sudan, Syria, São Tomé and Príncipe, Tanzania, Tajikistan, Timor-Leste, Togo, Turkmenistan, Tunisia, Uganda, Uzbekistan, Venezuela, Vietnam, Yemen, Zambia, Zimbabwe, China\* and India\*.

\* Nationals of China and India holding valid ordinary passports are exempt from the temporary visa requirement for tourism and business categories if they meet one of the following conditions: (a) They hold a valid visa, with a minimum validity of six (6) months, issued by the United States, Canada, the United Kingdom, Australia, or a Schengen State; or (b) They hold permanent residency in any of those countries.

# 4.2 Diplomatic, Official, Service, or Special Passports — Visa Exemption Agreements

Holders of diplomatic, official, service, or special passports from the following countries <u>must also obtain a visa in advance</u>:

Afghanistan, Albania, Andorra, Angola, Saudi Arabia, Armenia, Bahrain, Bangladesh, Benin, Bosnia and Herzegovina, Botswana, Burkina Faso, Burundi, Bhutan, Cabo Verde, Cameroon, Canada, Central African Republic, Chad, Comoros, Cook Islands, Cuba\*, Democratic Republic of the Congo, Republic of the Congo, Côte d'Ivoire, Djibouti, Egypt, Eritrea, Eswatini, Estonia, Ethiopia, Fiji, Gabon, Gambia, Ghana, Guinea, Guinea-Bissau, Equatorial Guinea, Iceland, Iran, Iraq, Ireland, Japan, Kazakhstan, Kenya, Kiribati, Kyrgyzstan, Lebanon, Lesotho, Liberia, Libya, Liechtenstein, Lithuania, Madagascar, Malawi, Maldives, Mali, Marshall Islands, Mauritania, Mauritius, Micronesia, Monaco, Mozambique, Myanmar, Namibia, Nauru, Nepal, New Zealand, Niger, Nigeria, Niue, North Korea, Norway, Oman, Pakistan, Palau, Papua New Guinea, Qatar, Rwanda, Samoa, San Marino, Senegal, Seychelles, Sierra Leone, Singapore, Solomon Islands, Somalia, South Sudan, Sri Lanka, Sudan, Syria, Tajikistan, Tanzania, Timor-Leste, Togo, Tonga, Turkmenistan, Tuvalu, Uganda, United Arab Emirates, United Kingdom, United States, Uzbekistan, Vanuatu, Yemen, Zambia, Zimbabwe.

\*For Cuban nationals, the visa exemption applies only to diplomatic passports and not to official passports.

### 5. ACCOMMODATION

Lima offers a wide range of accommodation, from international hotel chains to local hotels. You will have to make reservations and pay for the room directly. Foreign passport holders are exempt from accommodation (only) taxes at mayor hotel chains.

# 6. HEALTH REQUIREMENTS & MEDICAL SERVICES

# **Health requirements**

Peru does not require vaccinations for entry. However, you may need proof of vaccination against yellow fever when returning to your country. If you are considering visiting the Amazon region, it is strongly recommended to get a yellow fever vaccine.

### **Medical Services**

Any medical service provided by clinics, hospitals, pharmacies, or other health care institution, will have to be funded by the participants directly to the service provider. Hospital information, including a list of those who accept international insurance, will be available at the information desk located at the main meeting venue.

There are no longer COVID restrictions upon entering Peru.



Participants are responsible for making all necessary arrangements for life, health and other forms of insurance as they consider appropriate.

### 7. WEATHER

Lima and the Peruvian coast go through four seasons: Summer, from January to March; Autumn, from April to June; Winter, from July to September; Spring, from October to December.

The average temperature during October-November is 15 - 19 °C, and relative humidity can reach 74% to 94%.

Participants are advised to wear layers of clothing during the day and keep warm in the evening since it will be the middle of the spring season. Furthermore, the effects of El Niño may distort average weather patterns, and slight rain may be unusually expected in Lima during October.



# 8. CURRENCY

The currency in Peru, Sol (which means Sun in Spanish), is appreviated as PEN with a symbol of S/. One sol is further subdivided into 100 cents.

The American dollar is accepted in many commercial establishments, restaurants, and hotels. It is possible to exchange foreign currency at banks and exchange bureaus which are open from Monday to Friday, from 9:00 a.m. to 6:00 p.m., and on Saturdays until noon. Be aware of exchanging money at "street dealers".

The current exchange rates are aprox:

### **ATMs**

ATMs may be found in banks, pharmacies, drugstores, supermarkets, and shopping malls in all cities throughout the country, and most of them are connected to the Plus (Visa) and Cirrus (Mastercard) networks, American Express, and others.

You may withdraw money in soles or American dollars from these ATMs.

### **Credit cards**


**Visa, MasterCard, American Express, Dinners Club** and other major credit cards are widely accepted at hotels, restaurants, and shops. However, some restaurants and small shops accept only cash payments.

# **Tipping**

Service charge is included in most restaurants and hotels. However, rounding up bills to 10% is always appreciated.

### 9. ELECTRICITY

Power systems are 220 volts and 60 Hz.



Peru uses 3 different power outlets. Delegates can expect to find Type A/B, which is commong in North America as well as Type C, which is commong in most of Europe.

Participants are advised to bring their own adapters to plug into power sockets.

### **Internet services**

Free Wi-Fi facility will be available at the venue and meeting rooms. You will be given details of the wireless network connection when you register on-site.

All hotels listed above provide Internet access.

### 10. WORKING LANGUAGES

Peru's official languages are Spanish, Quechua and Aymara. However, Spanish is the most common one in Lima. English is not extensively used outside main hotels.

During the session, simultaneous interpretation in the six UN official languages (Arabic, Chinese, English, French, Russian and Spanish) will be provided in the main conference room.

# 11. EMERGENCY CONTACT INFORMATION

Long distance calls may be made from hotel rooms and international public phones. Whatsapp and similar services are available if you have Internet access. Pre-paid phone cards may be available at the hotel's front office. Please note that all charges for personal phone calls made from hotel rooms must be paid by users.
